POPS GUN CLUB, INC

APPLICATION FOR General MEMBERSHIP

This application for membership to Pops Gun Club is good for one year. This application for membership entitles each family to join Pops Gun Club Inc. In joining Pops Gun Club you will become a member of an organization that educates its members and supports shooting sports. In addition, you will support the existence of private ranges in the State of Florida and help maintain your right to enjoy shooting.

This application for membership is not an entitlement to shoot, nor does it entitle any member use of any facility for shooting.

The cost to join the club is \$100.00 per immediate family. This includes your spouse and your minor (under 18) children.

The cost of shooting varies depending on the event. As a member your spouse and minor children do not pay to shoot. The primary member will pay \$20.00 plus FL Tax 6% on most "member shoot" days.

Guests: General Members may bring up to 6 guests. However, a guest that uses the facility over 2 times are required to join the gun club.

Members are required to participate in 3 workdays per year, or 5 service hours per year.

Those that choose to forgo service work will be required to give a donation to our building fund in the amount of \$100.00. Funds will be used to improve the range and improve the grounds for our membership.

From time to time it may be necessary to assess the membership in emergencies for legal fees, or various other needs. The proposed assessment will be preceded by a member meeting and voted on by the general population of members before such assessment will be imposed.

Every member will be issued a member card with power to vote. Elections are held in July. No member holds any interest in the physical property in which the gun club is situated.

There are 3 classes of members. The first class includes Directors; and Officers and Service Personal. The Second are Gold Members and lastly General Members. General members are welcome to shoot when the calendar states "member shoot".

General Members need to be aware of the times on the calendar as well. Always expand the detail dialog box in order to note when the club opens and when it closes. The RSOs will not appreciate early, or late arrivals. The calendar should be checked the same day, or the evening before you come out to shoot. Especially in cases of extreme weather conditions such as summer. **We provide phone numbers for members to call if needed; however, a general member is never to use the number to ask to shoot on closed days, or to ask for the club schedule!** The "calendar" page on our web-site will tell you our schedule.

We are a NRA affiliated business that strictly adheres to NRA Safety Rules. Every member will be responsible to learn and practice safety. Our instructors are here to teach safety, but every member and guest has a responsibility to learn and adhere to all our gun club rules. Disciplinary actions will be adhered to in the case that A NRA RSO deems necessary.

Every member is to pick up their own mess and dispose of all items.

Violations will be fined via PayPal.

Failure to remove garbage from the field: \$30.00

Failure to remove trash off of the back berm: \$30.00

Failure to sweep and dispose of casings: \$30.00

Failure to take the cardboard off the sticks and the sticks out of the stand: \$20.00

Leaving used targets on the fire line: \$20.00

Damage to Steel; stands etc.: Gold Members will either pay replacement value of the item, or replace the item. No shooting will be allowed until payment, or fines are paid.

Orientation: Orientation is not required in order to shoot; however, it is the time that we show you how not to get fined and go over how to use the club. It is highly recommended that you attend orientation.

All of our shooting activities will include a NRA RSO and there will be no shooting without one.

All membership applications shall be legible with a good email and phone number.

This application does not contain all of the by-laws of the gun club. You may pick up the by-laws in the club office.

Memberships are transferable. In the case that you must sell your membership please let the buyer know that approval of the board is required before any use of the facility is allowed.
